#### **SPRING CLEANUP**

The date for our Annual Spring Cleanup is now tentatively set for May 2nd to run for about two weeks. There will be two large bins placed in front of Fire Station #2. Property owners are welcome to drop in their large items of trash. Please use the weekly trash service for household trash.

Any limbs and scrap lumber should be taken care of by burning it on your own property or removing it from the area. We pay for this according to weight. Avoid dumping tires, car batteries and cans of paint into the dumpsters as well because they carry special regulations for disposal.

The dumpsters cost is about \$450 each and we only have \$2000 in the budget allowed for cleanup.
